This stylish home is arranged over three floors offering well-proportioned bright rooms, with high specification kitchen with integrated appliances and sunny private rear garden.

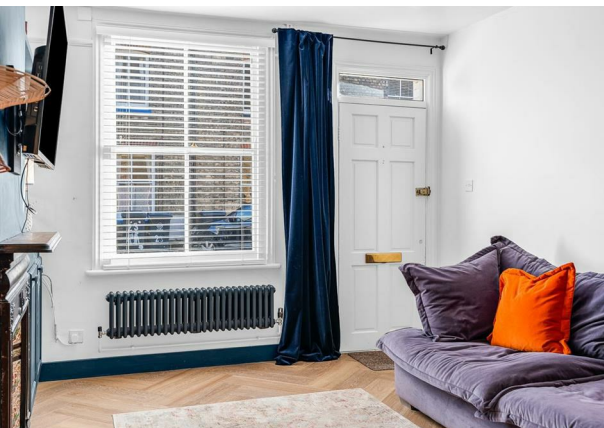
The ground floor of property offers a great size living room with wood flooring and fully fitted kitchen breakfast room with access to the garden.

To the first floor is a guest double bedroom with original fireplace, bedroom three and bathroom room. The top floor offers the master bedroom with the beautiful separate shower room.

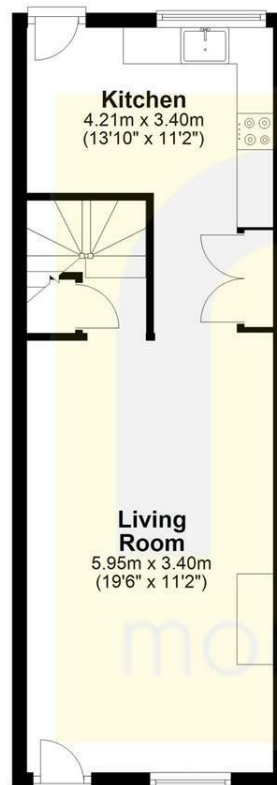
Outside there is a delightful rear garden, perfect for family fun and outside dining, with a good-sized lawn area- the best of both worlds!

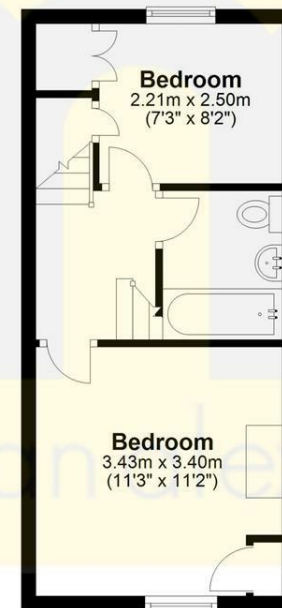




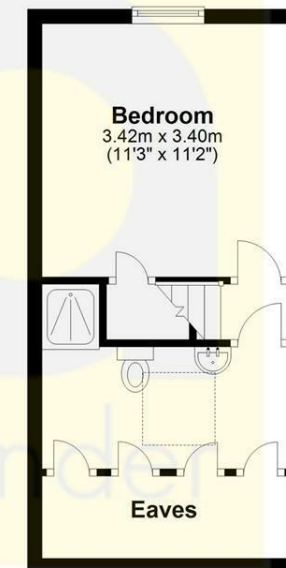
