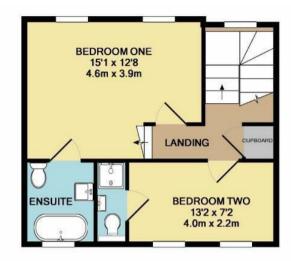


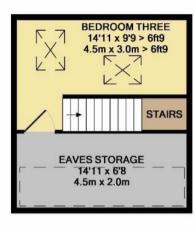






GROUND FLOOR APPROX. FLOOR AREA 406 SQ.FT. (37.7 SQ.M.)





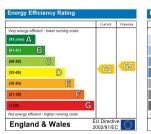
2ND FLOOR APPROX. FLOOR AREA 244 SQ.FT. (22.7 SQ.M.)

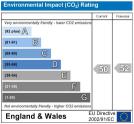
