Set in the picturesque hamlet of Hare Street, Timbers is a charming period cottage that blends character features with thoughtful modern updates, offering an inviting home suited to village living.

Surrounded by rolling countryside with scenic walks on the doorstep, the setting is as appealing as the property itself. The well-loved local pub, The Beehive, is within easy walking distance, while a delightful park just behind the home provides open green space to enjoy.

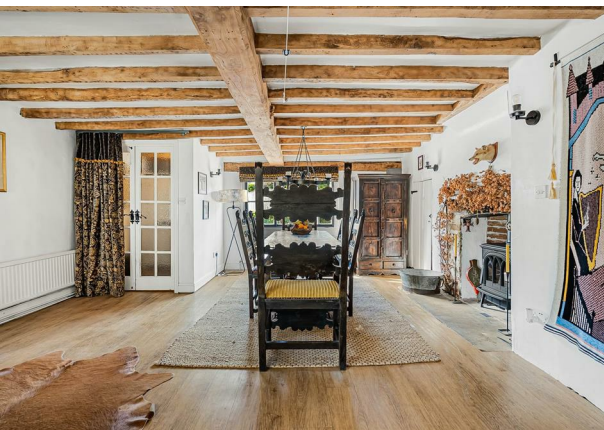
Sympathetically updated and stylishly presented, the property offers approximately 1,571 sq ft of accommodation across two floors. Period details including exposed timbers, fireplaces and distinctive architectural features sit comfortably alongside modern fittings.

An enclosed entrance hall leads into the impressive lounge/dining room, a characterful space with exposed timbers, front-facing windows and a fireplace with wood-burning stove. An opening framed with vertical beam studwork leads into the fitted kitchen, which features white quartz worktops, integrated appliances including a Neff dishwasher, and a Rangemaster Professional FX electric range cooker with induction hob. A stable door provides access outside.

To the rear is an atmospheric living room centred around a striking inglenook fireplace with wood-burning stove. Stone and brick flooring, exposed beams and front-facing windows enhance the cottage feel, while a full-height ceiling with galleried landing above adds a sense of space.

An inner lobby provides stairs to the first floor and access to a spacious family bathroom fitted with a modern white suite, bath with shower attachment, basin unit and WC, finished with tiled walls and flooring.

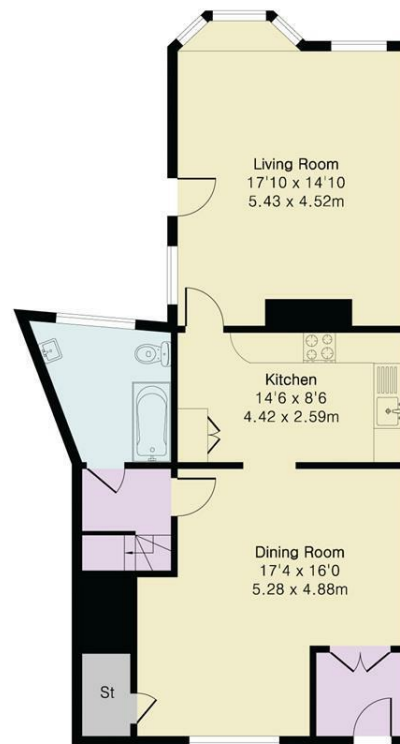




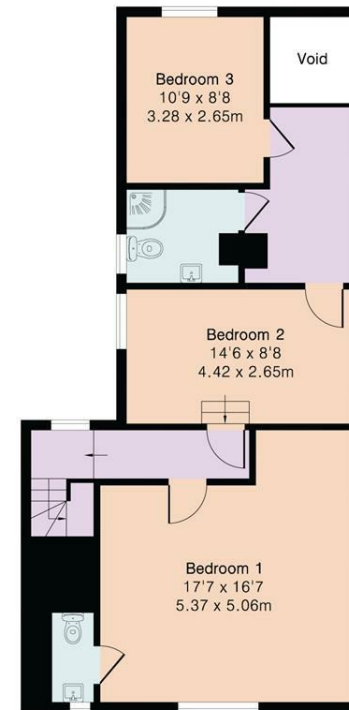
